



EXAMPLES OF PERMITTED MEDICATIONS - 2018

- **ADD/ADHD:** Strattera (atomoxetine)
- **Antacids/Heartburn:** Aciphex (rabeprazole), Carafate (sucralfate), Mylanta (aluminum hydroxide/magnesium/simethicone), Nexium (esomeprazole), Pepcid (famotidine), Prevacid (lansoprazole), Prilosec (omeprazole), Protonix (pantoprazole), Roloids (calcium carbonate/magnesium oxide), Tums (calcium carbonate), Zantac (ranitidine)
- **Anti-Anxiety:** Atarax (hydroxyzine), Ativan (lorazepam), Buspar (buspirone), Klonopin (clonazepam), Librium (chlordiazepoxide), Valium (diazepam), Vistaril (hydroxyzine), Xanax (alprazolam)
- **Antibiotics:** All products permitted
- **Anti-Depressants:** Anafranil (clomipramine), Celexa (citalopram), Cymbalata (duloxetine), Effexor (venlafaxine), Elavil (amitriptyline), Lexapro (escitalopram), Paxil (paroxetine), Pristiq (desvenlafaxine), Prozac (fluoxetine), Savella (milnacipran), Tofranil (imipramine), Wellbutrin (bupropion), Zoloft (sertraline)
- **Anti-Diabetics:** Actos (pioglitazone), Amaryl (glimepiride), Glucophage (metformin), Glucotrol (glipizide), Glynase (glyburide), Invokana (canaglifozin), Januvia (sitagliptin)
- **Anti-Diarrheals:** Imodium (loperamide), Kaopectate (bismuth subsalicylate), Lomotil (diphenoxylate/atropine), Peptol Bismol (bismuth subsalicylate)
- **Antifungals/Vaginal Medications:** Diflucan (fluconazole), Gyne-Lotrimin (clotrimazole), Lamisil (terbinafine), Lamisil AF (tolnaftate), Metrogel (metronidazole), Monistat (miconazole), Nystop (nystatin), Terazol (terconazole), Vagistat (miconazole)
- **Anti-Nausea:** Antivert (meclizine), Compazine (prochlorperazine), Dramamine (dimenhydrinate), Emetrol, Phenergan (promethazine), Reglan (metoclopramide), Vistaril (hydroxyzine)
- **Asthma/COPD:** Atrovent (ipratropium), Cromolyn, Pulmicort (budesonide), Singulair (montelukast), and Spiriva (tiotropium)
- **Cold/Allergy:** Actifed cold and allergy (chlorpheniramine/phenylephrine), Allegra (fexofenadine), Allegra-D (fexofenadine/pseudoephedrine)*, Benadryl (diphenhydramine), Chlorphen (chlorpheniramine), Clarinex (desloratadine), Claritin (loratadine), Claritin-D (loratadine/pseudoephedrine)*, Coricidin Cough and Cold (chlorpheniramine/dextromethorphan), Coricidin Maximum Strength Flu (acetaminophen, chlorpheniramine/dextromethorphan), Dayquil (acetaminophen/dextromethorphan/phenylephrine), Dayhist (clemastine), Delsym (dextromethorphan), Flonase (fluticasone), Mucinex (guaifenesin), Mucinex DM (guaifenesin/dextromethorphan), Nyquil Cold and Flu

(acetaminophen/dextromethorphan/doxylamine), Singulair (montelukast), Sudafed (pseudoephedrine)*, Zyrtec (cetirizine)

- *CAUTION: Pseudoephedrine is permitted when its concentration in urine is less than 150 micrograms per milliliter. If the athlete takes more than the recommended dosage on the pseudoephedrine product label, the athlete is at risk for an AAF (positive) pseudoephedrine result
- CAUTION: Vicks Vapor Inhaler is **PROHIBITED**
- CAUTION: Combination cold medications may contain prohibited substances
- Contraceptives: All Products Permitted
- Ear Medications: Cipro HC (ciprofloxacin/hydrocortisone), Ciprodex (ciprofloxacin/dexamethasone), Cortisporin (neomycin/polymixin B/hydrocortisone), Debrox (carbamide peroxide)
- Eye Medications: Artificial Tears (polyvinyl alcohol), Blephamide (sulfacetamide/prednisolone), Cortisporin (neomycin/polymixin B, hydrocortisone), Lacrisert (hydroxypropyl cellulose), Naphcon-A (naphazoline/pheniramine), Refresh (carboxymethylcellulose), Systane (polyvinyl alcohol), Visine-A (naphazoline/pheniramine)
- Laxatives/Stool Softeners: Colace (docusate), Dulcolax (bisacodyl), Ex-Lax (sennosides), Fibercon (polycarbophil), Fleet Enema, Glycolax (polyethylene glycol), Metamucil, Miralax (polyethylene glycol), Senna (sennosides), Senna Plus (sennosides/docusate)
- Local Anesthetics: Benzocaine, Chloroprocaine, Marcaine (bupivacaine), Mepivacaine, Pramoxine, Prilocaine, Ropivacaine, Tetracaine, Xylocaine (lidocaine)
- Muscle Relaxants: Flexeril (cyclobenzaprine), Lioresal (baclofen), Robaxin (methocarbamol), Skelaxin (metaxalone), Soma (carisoprodol), Zanaflex (tizanidine)
- Pain Medications: Advil (ibuprofen), Aleve (naproxen), Aspirin, Celebrex (celecoxib), Codeine, Hydrocodone, Ketoprofen, Lortab (hydrocodone/acetaminophen), Lyrica (pregablin), Mobic (meloxicam), Neurontin (gabapentin), Norco (hydrocodone/acetaminophen), Piroxicam, Tylenol (acetaminophen), Ultram (tramadol), Vicodin (hydrocodone/acetaminophen)
- Topical Medications: Anucort HC (hydrocortisone), Aspercreme (trolamine salicylate), Ben-Gay (methyl salicylate/menthol), Biofreeze, Caladryl (promaxine), Chiggerex (benzocaine), Cortizone-10 (hydrocortisone), Icy Hot (methyl salicylate/menthol), Lidoderm (lidocaine), Proctofoam (pramoxine), Sportscreme (salicylate salts), Trixaicin (capsaicin)
- Sedatives/Sleep Aids: Ambien (zolpidem), Dalmane (flurazepam), Diphenhydramine, Halcion (triazolam), Lunesta (Eszopiclone), Restoril (temazepam), Rozerem (ramelteon), Sonata (zaleplon), Unisom (diphenhydramine)
- Thyroid Replacement Medications: Armour Thyroid (thyroid), Cytomel (liothyronine), Levoxyl (levothyroxine), Synthroid (levothyroxine), Thyrolar (liotrix)
