The following players must start at Stage III:

- 1) Current LPGA Tour members (except for LPGA Tour Class A members who have not competed in an official LPGA tournament in the previous three years).
- 2) Ten (10) players from the 2012 LPGA Symetra Tour year-end money list (in order of their position on the list) who do not earn LPGA status via the Volvik Race for the Card and are not otherwise qualified for Stage III.
- 3) The top 70 and ties from Qualifying Stage II.

Stage III of Qualifying School will be 90 holes of stroke-play competition. The field will be cut after 72 holes to the low 70 players and ties. The final round will be played on the Champion course (unless otherwise designated by LPGA). Every player must have a caddie. No golf carts will be used for the event.

Status received upon completion of 90 holes: Players who finish within the top-40 and those players tied for 40th place will receive LPGA membership for the 2013 LPGA Tour season. All other players participating in Stage III will receive 2013 Symetra Tour membership. Category status and number of membership cards will be determined by LPGA prior to the commencement of the Qualifying School Stage III competition.

All players in the field for Qualifying School Stage III must register Monday, November 26 from 8:00AM-4:00PM. There will be a **MANDATORY** rookie orientation on Monday, December 3 from 8:00AM-5:00PM. All contestants awarded any 2013 LPGA Tour priority status who were not on the LPGA Tour in 2010, 2011, or 2012 must attend the meeting.

By submission of this entry the player agrees to the following:

- I certify that the information provided in this Application is true and accurate.
- I have noted requirements for acceptance of entries, notice of withdrawal and registration at the Qualifying Tournament site. I further understand that play shall be subject to and conducted in conformity with the USGA Rules of Golf (except as modified by the LPGA Tournament Regulations or Local Rules, applicable provisions of the LPGA Constitution and Bylaws, and any additional policies and procedures promulgated by the LPGA).
- I agree that this entry is subject to rejection at any time, for any reason (including during the Tournament) by the Tour, in its sole discretion.
- I understand that, by entering Stage III of Qualifying School, I voluntarily and willingly agree to be subject to and comply with the LPGA's Anti-Doping Protocol and Program, which are incorporated herein by reference. - I agree that the responsibility for ensuring this application is received by the Tour by no later than 5:00 PM EDT on the entry deadline date is mine alone and that this application will be automatically rejected if received by the Tour after such date and time. I agree the risk of delay or error in transmission lies solely with me and that the Tour has no liability with respect to any such delay or error and the consequences there from, including rejection of this entry.
- All television, radio, photo, motion picture, Internet, and any other media rights, whether now known or hereafter devised, for players participating in Stage III of this Qualifying School shall be granted and assigned to LPGA by virtue of my entry in the Qualifying School and signature below. All such rights granted and assigned to LPGA are thereafter the property of and reserved by LPGA without restriction. Each participant further agrees to refrain from taking any action which would interfere with LPGA's ownership of such specified rights.
- LPGA reserves the right, at its sole discretion, to modify the Qualifying School related information and terms herein.
- Although membership is based principally on the Qualifying School competition, LPGA reserves the right to apply other reasonable criteria (including, but not limited to; character; conduct; financial responsibility etc.) to all applicants for membership.
- I certify that I am physically fit and able to participate in Stage III of the Qualifying School, and I voluntarily assume all risk and danger incidental or related to my entry and/or participation at the Qualifying School and all related activities, from both known/unknown causes and both obvious/hidden conditions, and release Ladies Professional Golf Association, FGTA, LLC, LPGA International, and their respective affiliates, partners, sponsors, officers, directors, employees, agents, volunteers, owners, managers, and licensees (Releasees) from any and all liability of any kind related to such risk. I further agree to indemnify and hold harmless Releasees from and against any/all liability they may incur due to my acts, omissions and conduct while present at or participating in any Qualifying School activity. The foregoing release, waiver and indemnity is intended to be as broad and inclusive as is permitted in the State of Florida. Player agrees Florida law shall govern any and all disputes involving Releasees. Any disputes involving the Releasees shall be resolved by arbitration in the State of Florida pursuant to the Commercial Rules of the American Arbitration Association then in force. A judgment upon the award rendered by the arbitrators shall be final and non-appealable, and may be entered in any court having jurisdiction thereof.
- I(i) give my permission to receive emergency medical treatment; and (ii) agree to indemnify, waive, release, covenant not to sue, and forever discharge Releasees for any and all liability or claims arising out of such treatment.
