



2027 EPSON TOUR PRIORITY STATUS FOR STANDARD ELIGIBILITY TOURNAMENTS

Subject to approval of the Epson Tour, availability of places in tournament fields as determined by the Epson Tour, and any modified eligibility statement applicable to and posted for a particular tournament, the following order of priority will be used to complete the field for Standard Eligibility Tournaments:

- A. **Top 80**: Professional Members finishing #11 - 80 (and ties) on the previous season-ending Points List. Priority is based on the order of the list. Ties will be broken by Members' positions on the previous season-ending Money List.
- B. **Winner**: Players who have won one or more Official Tournaments during the current season or the previous season. Priority is based on the earliest date of such wins. To be included in this category:
 - Amateur Players and Members must turn professional.
 - Non-Member Players must be eligible for and accept membership prior to March 1 of the season following the win.
- C. **Final Qualifying**: Players finishing a minimum of 72 holes at the previous year's Final Qualifying Stage of the LPGA Q-Series. Players will be ranked based on the order of their finish at Final Qualifying Stage. Ties will be broken in the following order: lowest final round of Final Q; lowest 4th round; etc. until the tie is broken. If Players are still tied, ties will be broken by a match of score cards beginning with the 18th hole of the final round and working backwards.
- D. **LCAP Top 5**: Players ranked #1-5 in the Final LCAP Ranking will be eligible for this category for the remainder of the season in which the Final LCAP Ranking is published and for the following season. Priority is based on the order of each ranking list. The most recent "class" will be ranked ahead of the previous year "class". A Player must be eligible for and accept Epson Tour membership to be included in this category.
- E. **Advanced from Qualifying**: Players at the previous year's Qualifying Stage of LPGA Q-Series, who qualify to advance from Qualifying Stage to Final Qualifying Stage, but either do not compete in or do not complete 72 holes at Final Qualifying Stage. Players will be ranked based on the order of their finish at Qualifying Stage. Ties will be broken in the following order: lowest final round; lowest 3rd round; lowest 2nd round; lowest 1st round; match of score cards beginning with the 18th hole of the final round and working backwards.
- F. **Non-Member Top 60**: Non-Member Professionals who, as of the conclusion of the last Official Tournament of the previous season, earned the number of Points during such season in Official Tournaments with a cut that is equal to or greater than the number of Official Points won by the Member who was in 60th place on the Points List at that time. Priority is based on the number of Points won in such tournaments. Ties will be broken by the earliest time at which the Non-Member earned the Points necessary to be included in the category. A Player must be eligible for and accept Epson Tour membership to be included in this category.
- G. **Current Season Top 80**: Members in the Top 80 of the current season's Points List after the First Reshuffle Tournament with priority based on the order of the list. For the remaining Official Tournaments of the season, Members in the Top 80 on the current season's Points List after the Second Reshuffle Tournament. Priority is based on the order of the list. Ties are broken by the Members' positions on the current season's Priority List as of the Commitment Deadline for each respective reshuffle tournament.
- H. **LPGA Tour Member**: LPGA Tour members on the current-season's LPGA Priority List. Beginning in 2027, an LPGA Member may only choose membership in this category two times in her career. Priority determined in the following order (maximum of 12 players):
 - On a week when both Tours play, priority will be given to LPGA Tour Members based on their position on the current season's LPGA Priority List as of the Commitment Deadline. An LPGA Tour Member may only play in the Epson event through this category if she is not eligible to gain entry into the LPGA field as of the Commitment Deadline for the LPGA event; unless she is playing a test event per the LPGA Medical Extension of Status Policy.
 - On an off-week for the LPGA, priority will be given to LPGA Tour Members based on their position on the current season's LPGA Priority List beginning with the 61st player on the list and working downward.

- I. **Current Season Reshuffle:** After the First Reshuffle Tournament, Members in Categories J through O who have earned Points will be re-seeded into Category G. Members placed into Category I will be ranked in the order of their position on the current season's Points List through the First Reshuffle Tournament. Members will remain in this category until the next reshuffle. After the Second Reshuffle Tournament, Members in Categories I, and J through O, who have earned Points will be re-seeded into Category I. Members placed into Category I will be ranked in the order of their position on the current season's Points List through the Second Reshuffle Tournament. Members will remain in this category for the remainder of the calendar year. For all reshuffles, ties are broken by the Members' positions on the current year's Priority List as of the Commitment Deadline for each respective reshuffle tournament.
- J. **Previous Season's LPGA Tour Member:** Previous season's LPGA Tour members without current season LPGA membership status; and previous season's LPGA Tour members who were unable to compete at or complete the previous year's LPGA Qualifying Tournament for medical reasons and/or exceptional circumstances of an unavoidable nature, as approved and determined solely by the LPGA. Players will be ranked in the order of their position on previous season's LPGA Priority List as of January 1 of the previous year. Players will be ranked in the order of their position on previous season's LPGA Priority List as of January 1 of the previous year.
- K. **Qualifying Top 80:** Players finishing in the Top 80 (and ties) at the previous year's Qualifying Stage of LPGA Q-Series, who do not advance to Final Qualifying. Players will be ranked based on the order of their finish at Qualifying. Ties will be broken in the following order: lowest final round; lowest 3rd round; lowest 2nd round; lowest 1st round; match of score cards beginning with the 18th hole of the final round and working backwards.
- L. **LCAP Nos. 6-10:** Players ranked #6-10 in the Final LCAP Ranking will be eligible for this category for the remainder of the season in which the Final LCAP Ranking is published and for the following season. Priority is based on the order of each ranking list. The most recent "class" will be ranked ahead of the previous year "class". A Player must be eligible for and accept Epson Tour membership to be included in this category.
- M. **Nos. 81-100:** Professional Members finishing Nos. 81-100 (and ties) on the previous season-ending Points List. Priority is based on the order of the list. Ties will be broken by Members' positions on the previous season-ending Money List.
- N. **Qualifying Finisher:** Remaining players who complete 72 holes at the previous year's Qualifying Stage of LPGA Q-Series (i.e., players not included in Category K above). Players will be ranked based on the order of their finish at Qualifying Stage. Ties will be broken in the following order: lowest final round; lowest 3rd round; lowest 2nd round; lowest 1st round; match of score cards beginning with the 18th hole of the final round and working backwards.
- O. **Advanced from Pre-Qualifying:** Players at the previous year's Pre-Qualifying Stage of LPGA Q-Series, who qualify to advance from Pre-Qualifying Stage to Qualifying Stage and are either (1) unable to compete in Qualifying Stage or (2) unable to complete 72 holes at Qualifying Stage. Players will be ranked based on the order of their finish at Pre-Qualifying Stage. Ties will be broken in the following order: lowest final round; lowest 2nd round; lowest 1st round; match of score cards beginning with the 18th hole of the final round and working backwards.
