PRE-QUALIFYING STAGE ELIGIBILITY STATEMENT

Entries Open: Wednesday, July 8, 2026, at 10:00 a.m. ET

Entry Deadline: Tuesday, September 1, 2026, at 5:00 p.m. ET

Late Entries will not be accepted.

Dates:

- **Practice Round:** Tuesday, September 22, 2026
- **Competition Rounds:** Wednesday, September 23 - Friday, September 25, 2026
- **Cut:** Top 65 and ties after 36 holes
- **Rain Date:** Play may be extended beyond Friday, September 25, 2026, if needed, to complete 54 holes.

Location: 3 distinct locations – each player will play one location only

- Indian Wells Country Club, Indian Wells, CA (Classic course), **OR**
- LPGA International, Daytona Beach, FL (Jones course), **OR**
- TPC Houston, Sugar Land, TX (Pecan Course)

The Players below are required to Pre-Qualify and must enter by the Entry Deadline:

1. 2026 Epson Tour Members not ranked or ranked outside of the Top 125 (and ties) on the 2026 Epson Tour Race for the Card Points List **following the conclusion of the Dream First Bank Charity Classic.**
NOTE: An Epson Tour Member who plays into the Top 125 (and ties) at the conclusion of Murphy USA El Dorado Shootout will be moved to begin the qualifying process at the Qualifying Stage in Venice, FL.
2. All amateur and professional Players (*who are not current LPGA Tour Members*) and are not ranked or ranked outside of the Top 400 on the Rolex Women's World Golf Rankings **as of September 1, 2026.**

Venue Selection:

1. Players must select a venue at time of entry. Once a venue is full (120 Players) it will no longer be available for selection.
2. Requests to change venue after entry will be subject to availability and reviewed in order of request. Please request a venue change [HERE](#), or through the link on the website. **No venue changes will be made after the Entry Deadline.**
3. If the total number of entries combined exceeds 360, the field at one or more venues may be expanded to accommodate additional Players.



QUALIFYING STAGE ELIGIBILITY STATEMENT

Entries Open: Wednesday, July 8, 2026, at 10:00 a.m. ET

Entry Deadline: Tuesday, October 6, 2026, at 5:00 p.m. ET

Late Entries will not be accepted.

Tournament Dates:

- **On-Site Registration for Players & Caddies:** Sunday, October 11, 2026, between 8:00 a.m. – 4:00 p.m.
- **Practice Rounds:** Sunday, October 11 and Monday, October 12, 2026
- **Tournament Rounds:** Tuesday, October 13 – Friday, October 16, 2026, no cut
- **Rain Date:** Play may be extended beyond Saturday, October 17, if needed, to complete 72 holes.

Location: Plantation Golf and Country Club, Venice, FL (Bobcat and Panther courses)

The Players below are exempt to Qualifying:

1. Epson Tour Professional Members ranked #1-125, including those tied for 125th place, on the *2026 Epson Tour Race for the Card Points List as of 5pm ET on September 1, 2026*.
 - a. **Note:** An Epson Tour Member who is entered for Pre-Qualifying by the September 1 entry deadline and subsequently moves inside the Top 125 at the conclusion of the 2026 Murphy USA El Dorado Shootout, will be withdrawn from the Pre-Qualifying Tournament and moved by the Tour to begin the qualifying process at the Qualifying Tournament.
2. Epson Tour Members ranked #36-125, including those tied for 125th place, on the *2026 Epson Tour Race for the Card Points List as of the conclusion of the 2026 Epson Tour Championship*.
3. LPGA Tour Members ranked outside of the Top 150 and ties on the *2026 LPGA Race to CME Globe Points List as of the conclusion of the 2026 LOTTE Championship presented by Hoakalei*.
4. Professional Players who, **as of September 1, 2026**, earned a number of equivalent points in Official Epson Tour tournaments that is equal to or greater than the number of Epson Tour Race for the Card Points earned by the Epson Tour Member who is in 100th place on the *2026 Epson Tour Race for the Card Points List as of September 1, 2026*
5. Players ranked #1-5, including those tied for 5th place, on the 2026 ANNIKA Women's All Pro Tour Callaway Race to Qualifying as of **September 14, 2026**.
6. Players ranked #2-10 on the 2025-2026 LPGA Collegiate Advancement Pathways (LCAP) Rankings as of the first rankings update that includes the results of the 2026 NCAA Division I National Championships.
7. Players ranked #2-10 on the women's World Amateur Golf Rankings as of the first rankings update that includes the results of the 2026 NCAA Division I National Championships.

Note: The #1 ranked player is exempt to Final Qualifying, provided she competes at Final Qualifying as a professional. If the #1 ranked player does not intend to turn professional by Friday, November 6, 2026, she may instead enter and compete at the Qualifying Stage Tournament as an amateur.
8. The top 5 Players, not already exempt in #6 and #7 above, from the *Women's Individual NCAA Division I National Collegiate Golf Rankings* as published on *Scoreboard Powered by Clipd*, as of the first rankings update following the conclusion of the NCAA Division I National Championships.
9. Players ranked #1-10 on the women's World Amateur Golf Rankings **as of September 1, 2026**.
10. Winner of the 2026 Juli Inkster Senior Award (Division I).
11. Winner of the 2026 ANNIKA Award (College Player of the Year Award).
12. Winner of the 2026 WPGA Player of the Year Award (Division I).
13. Any Player who began the current season with an LPGA Medical or Maternity Extension of Status and subsequently lost her LPGA Tour Membership at the end of her Extension of Status, provided that there were 2/3 or fewer of the Epson Tour tournaments remaining on the schedule when her Extension of Status ended.
14. Players, not otherwise exempt to Final Qualifying, who are ranked within the Top 400 on the Rolex Women's World Golf Rankings **as of September 1, 2026**. Players will be ranked in the order of their position on the list as of the entry deadline.
15. Players may be moved from Final Qualifying to Qualifying as described in the criteria for Final Qualifying.



FINAL QUALIFYING STAGE ELIGIBILITY STATEMENT

Entries Open: Wednesday, September 2, 2026, at 10:00 a.m. ET

Entry Deadline: Tuesday, October 6, 2026, at 5:00 p.m. ET

Late Entries will not be accepted, except as noted below.

Tournament Dates: (NOTE: New Dates for 2026)

- **Onsite Registration Players & Caddies:** Tuesday, November 17, 2026, 8:00 a.m. – 4:00 p.m., local time
- **Practice Rounds:** Monday – Wednesday, November 16 – 18, 2026.
- **Cut:** after 72 holes; cut number TBD
- **Competition Rounds:** Thursday – Monday, November 19 - 23, 2026.
- **Rain Date:** Play may be extended beyond Monday, November 23, if needed, to complete 90 holes.

Location: Robert Trent Jones Golf Trail, Magnolia Grove Golf Course (Falls and Crossings courses); Mobile, AL.

The Players below are exempt to Final Qualifying and MUST ENTER BY THE COMMITMENT DEADLINE

1. 2026 LPGA Tour Members ranked #101-150, including those tied for 150th place, on the 2026 LPGA Race to CME Globe Points List at the conclusion of the 2026 LOTTE Championship presented by Hoakalei.
2. 2026 Epson Tour Members ranked #11-35, including those tied for 35th place, on the season-ending 2026 Epson Tour Race for the Card Points List.
3. Players ranked #1 - #75 on the Rolex Women's World Golf Rankings **as of October 6, 2026**. If more than 10 Players apply through this Category, remaining Players may be moved to start the qualifying process at the Qualifying rounds.
4. The Player ranked #1 on the 2025-2026 LPGA Collegiate Advancement Pathways (LCAP) Rankings as of the first rankings update that includes the results of the 2026 NCAA Division I National Championships. Must enter and play as a Professional.
5. The Player ranked #1 on the women's World Amateur Golf Rankings as of the first rankings update that includes the results of the 2026 NCAA Division I National Championships, provided she did not compete in the Qualifying Stage.
 - a. **Note:** If the player qualified for this exemption does not intend to turn professional by Friday, November 6, she may instead enter and compete at Qualifying as an amateur.

The Players below are exempt to Final Qualifying and WILL BE LATE ENTERED WHEN IDENTIFIED. Eligible Players should contact Brittany Woods by email at brittany.woods@lpga.com for late entry instructions.

6. 2026 LPGA Tour Members ranked #101-150, including those tied for 150th place, on the 2026 LPGA Race to CME Globe Points List at the conclusion of the 2026 ANNIKA driven by Gainbridge at Pelican. **LPGA Members who were eligible through criteria #1 above but did not enter by the October 6 deadline, ARE NOT eligible to late enter through this criterion.**
7. 2026 LET Members ranked #1-10, including those tied for 10th place, on the 2026 LET Order of Merit Points List at the conclusion of the last LET tournament scheduled to finish prior to November 16, 2026. Players qualifying through this category will be permitted to late enter on November 16, 2026.
